Tax on Cockfight Promoter for Mayor's Permit:

- 1, 650/day during "derby" cockfight involving Two (2) cocks
- 2, 200/day during "derby" cockfight involving Three (3) cocks
- 2, 750/day during "derby" cockfight involving Four (4) cocks
- 3, 300/day during "derby" cockfight involving Five (5) cocks
- 3, 500/day during "derby" cockfight involving Six (6) cocks or more

Special cockfights (Pintakasi): P 500.00/ day
 on ordinary cockfights: P 50.00/sultada
 derby: P 100.00/sultada

A. Imposition of Fee

There shall be imposed the following fees, taxes and/or charges exclusive of the other fees for business permits and other charges prescribed under the Revenue Code:

a. Franchise Fee (Good for 10 years)	P 10,000.00	g. Promoters	P 550.00 per a
b. Licensing Fee (One-time payment)	P 5,000.00	h. Gaffers	P 250.00 per a
c. Application Filing Fee	P 500.00	i. Referee	P 250.00 per a
d. Renewal of Licensing Fee (Annual)	P 5,000.00	j. "Taga-Gamot"	P 200.00 per a
e. Renewal of FRANCHISE TO OPERATE every after 3 years	P 10,000.00		
f. Bet takers	P 250.00 per annum		

B. Special Permit Fees shall likewise be paid for the following:

- a. Two- Cock Derby P 500.00
- b. Three- Cock Derby P 1,000.00
- c. Four- Cock Derby P 1, 500.00
- d. There shall be collected the amount of P 50.00 for every "sultada" from the owner of the winning cock to be remitted to the local treasury. The owner of the cockpit shall be responsible in deducting the said amount from the winner.
